## Instructions — Exotic CWD Susceptible Species Inventory

This form was created to facilitate the reporting of movements of Exotic CWD Susceptible Species as required by Texas Animal Health Commission (TAHC) rule (Title 4, Part 2, Chapter 40, Rule §40.5 of the Texas Administrative Code). To view the CWD rules, go to the Statutes & Rules page of the TAHC website and click on the [Texas Administrative Code](#) link.

### Form Completion

- **PIN or LID:** Unique Premises Identification number received from the TAHC Central or Region Offices. Herd owners may call either office to obtain this number.
- **County:** County where premises is located.
- **Date:** Date inventory is completed.
- **Owner's Name:** Name of owner or contact person such as ranch manager.
- **Ranch Name:** Name of facility where exotic susceptible species are located. If ranch name is the same as owner name, write the owner name in this block.
- **Mailing Address:** Mailing address of premises.
- **Phone:** Phone number of contact person.
- **Alternate Phone:** Additional phone number of contact person
- **Email Address:** Email address of contact person
- **Physical Location of Herd (911 Address or description):** Physical location information in 911 address format (*example: "123 FM 71"*) or in descriptive format (*example: "On Hwy 71 3 miles south of intersection of Hwy 71 and US 290"*).
- **Latitude/Longitude:** Lat/Long coordinates should be obtained at the entrance to the premises where the animals are located. These coordinates should be recorded in decimal degrees format. If you are not able to obtain coordinate data for the premises, leave this blank.
- **Estimated Current Inventory (animals 16 months and older):** Provide an estimated number of each species on the premises as of the date of the inventory.
- **Signature:** The inventory form must be signed by the person responsible for the animals. When completing and submitting the form electronically, please type in the name of the authorized person submitting the inventory.
- **Must be submitted by April 1st of each year to TAHC.**

### Form Submission

It is the responsibility of the herd owner to submit this completed form to the TAHC.
