Certificates of Veterinary Inspection

Texas is going electronic!

The Texas Animal Health Commission (TAHC) will begin to phase out the sale and acceptance of paper certificates of veterinary inspection (CVIs) according to the timeline below.

- **January 1, 2026:** TAHC will no longer accept paper CVIs for imports. TAHC will require all import CVIs, for [interstate movement into Texas](#), to be electronic.
- **February 1, 2026:** TAHC will no longer offer online ordering of paper CVIs.
- **June 1, 2026:** TAHC will no longer offer paper CVIs for purchase.
- **January 1, 2027:** TAHC will no longer accept paper CVIs for imports or exports. TAHC will require all interstate and intrastate CVIs to be electronic.

Important: To purchase and issue Certificates of Veterinary Inspection, veterinarians must have the credentials listed below. Use the links to check your status.

- Current [USDA Category II](#) accreditation
- Current Texas veterinary license from the Texas Board of Veterinary Medical Examiners (TBVME)
- Active status in the TAHC Authorized Personnel Program (TAPP)

 - TAHC eCVIs must be completed at the time of purchase.
 - TAHC eCVI price is \$7 + a **non-refundable** Texas.gov convenience fee that covers payment processing and the maintenance of the Texas.Gov infrastructure.

- It is my responsibility to take reasonable care to protect, secure and prevent the misuse of my TAHC eCVI account and password.
- It is my responsibility to immediately report to TAHC the deliberate or accidental misuse of my eCVI account.
- I understand that for data security reasons I will be required to change my password every 60 days.
- I agree to issue eCVIs in my name only and in accordance with applicable standards, regulations or laws of the TAHC, TBVME, and USDA.
- I understand that an eCVI is a government record and that making a false entry or alteration to an eCVI is a criminal violation pursuant to Texas Penal Code Section 37.10.
- I understand and agree that an eCVI must be accurate and fully completed before it is issued.
- I understand that it is my responsibility to maintain current contact information.
- I understand that eCVIs must be purchased one at a time (no bulk purchases) and that payment must be made at the time the eCVI is ordered.
- I understand that eCVIs must be purchased and completed in a single browser session. It is not possible to "save" a partially completed eCVI.
- I understand the fee for each eCVI is \$7 + a non-refundable Texas.gov convenience fee that covers payment processing and the maintenance of the Texas.Gov infrastructure. Payment must be made online by credit card.
(Note: Your payment information will not be stored by TAHC or Texas.gov.)
- I understand that eCVI credit card payments require entry of the card **CVV (sometimes referred to as CVC or security code)** and the **zip code of the billing address associated with the card**.
- I understand that upon completion, the eCVI will automatically be emailed to TAHC, the destination state's animal health officials, and the issuing veterinarian. Emails will be sent from no-reply@tahc.texas.gov; please check your email preferences to ensure eCVI emails don't end up in your Junk/Spam folder.
(Note: The completed eCVI will also display as a PDF and may be saved and/or printed.)

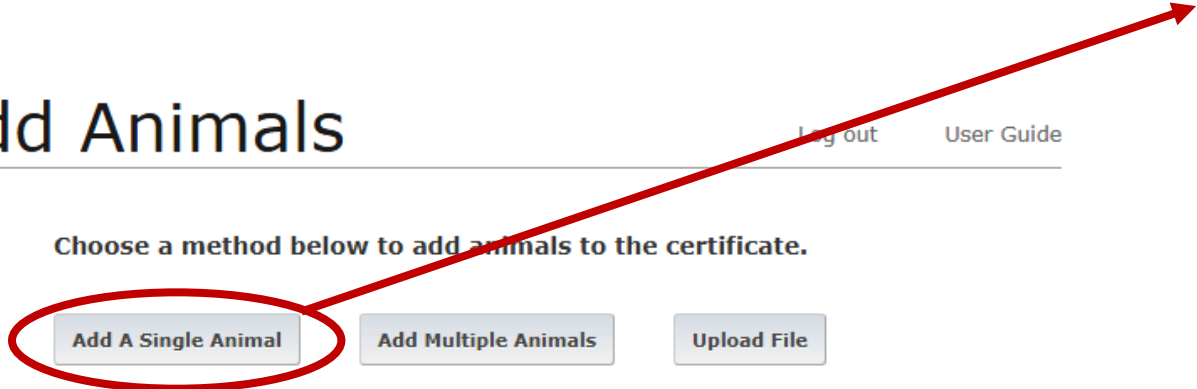

Options for Adding Animals

- “Add A Single Animal”
 - Animals can be added individually using the feature in the **previous** slide
 - Good option if you have a small load of different species traveling
- “Add Multiple Animals”
 - Good option if you have a shipment of animals that are the same species, age, and sex (ex: three 1-year old brangus steers)
- “Upload File”
 - Many animals can be added at once using the feature in the **following** slide
 - Good for adding 5+ animals at once so you don't have to add them individually
 - You are **not required** to use this feature if you do not want to
